SCHOLARSHIPS AFTER 10+2

On-Admission Scholarships:

- Scholarships begin in the **1st year** of the programme.
- For the **2nd year onwards**, continuation scholarship rules apply.

Important Notes:

- The aggregate percentage for eligibility will be calculated based on marks scored in **English** and **three academic subjects** (compulsorily including subjects of eligibility), excluding **Physical Education, Fine Arts, Performing Arts**, or any **Vocational/Non-Written subjects**. These subjects will be considered only for their respective select programmes.
- Students are required to pay the **full fees** for **Semester 1**, and any excess amount due to the scholarship will be adjusted against the payment for **Semester II**.
- The grant of scholarships is subject to the approval of the **Scholarship Committee**.
- A limited number of scholarships are available on a **first-come, first-served** basis.
- Candidates securing the required percentages must fill out the **IILM University Application Form**.
- In the absence of relevant mark sheets, scholarship applications will not be considered.
- Scholarships will be granted **only on the tuition fee**.
- **No two scholarships** can be combined.

SPORTS SCHOLARSHIP CRITERIA

To be eligible for the Sports Scholarship, candidates must meet the following criteria:

- 1.**Minimum Academic Eligibility:** Applicants must fulfil the academic requirements outlined in the Admission Brochure for their respective programme. Ensure you review the specific criteria for your chosen course to confirm eligibility.
- 2.**Age Limit:** Candidates must be 23 years old or younger as of July 31, 2025. This ensures that the scholarship supports young athletes in their educational journey.
- 3.**Participation Requirement:** Candidates must demonstrate regular participation in their chosen sport for a minimum of three years. This includes involvement in international, local, state, or national-level competitions. Documentation, such as certificates or letters from coaches, may be required to verify participation and level of achievement.

CONTINUATION CRITERIA: ACADEMIC MERIT

The Sports Scholarship is granted on an annual basis for the first year of the programme. For continuation into the second and subsequent years, recipients must adhere to the following conditions:

- **Academic Performance:** Scholars must maintain a minimum CGPA of 7 (or equivalent academic performance) and attendance of minimum 50% as specified in the scholarship policy. This ensures that student-athletes are balancing both their academic and athletic commitments effectively.
- **Sport Participation:** Continued eligibility requires ongoing active participation in the respective sport. Scholars must engage in competitions and training, demonstrating commitment to their sport.
- **Review Process:** Scholarship renewal will be subject to a review process at the end of each academic year. Recipients may be required to submit documentation of their academic performance and sports involvement.
- **Adherence to Policies:** Scholars must comply with all institutional policies and regulations, including any specific requirements set forth in the scholarship policy.

By meeting these criteria, scholars can secure their scholarship for the duration of their programme, supporting their academic and athletic ambitions

MARTYR'S SCHOLARSHIP

100% tuition fee waiver for Wards of Martyrs of the programme.

Criteria for Admission: The Martyr's Scholarship is designed to honour the sacrifices of those who have served the nation. To be eligible for this scholarship, candidates must meet the following criteria:

- **Academic Eligibility:** Candidates must fulfil the minimum academic eligibility requirements for the respective program as outlined in the Admission Brochure. Candidates must also successfully pass through the selection process established by the institution.
- **Scholarship Amount:** Selected students will receive a 100% scholarship on tuition fees, subject to the decision of the Scholarship Committee.
- **Fee Adjustment:** The scholarship will be awarded after the candidate joins the programme. Any excess fee paid by the student will be adjusted against the academic fees of the following year.
- **Documentation Requirement:** The qualifying act that led to the martyrdom must be in the line of duty. Applicants are required to submit documentary evidence to substantiate their application and justify the scholarship.
- **Eligibility for Wards of Martyrs:** The scholarship provides a 100% tuition fee waiver for the first year of the programme for the wards of martyrs from the following organisations: Army, Navy, Air Force, Assam Rifles, Special Frontier Force, Indian Coast Guard, CRPF (Central Reserve Police Force), BSF (Border Security Force), ITBP (Indo-Tibetan Border Police), CISF (Central Industrial Security Force), SSB (Sashastra Seema Bal), State Police.

FEE WAIVERS

Girls' Fee Waiver

To promote gender equality and encourage female education, a fee waiver of 10% is available for female students enrolled in any program. Key details include:

Eligibility:

This waiver is applicable to female candidates who:

- Have a family income of less than ₹8 lakhs per annum.
- Income Certificate issued by competent authorities (e.g., Tehsildar, Revenue Officer)

For continuation of 10% fee waiver from the second year onwards, students must:

- Maintain a minimum 75% attendance record
- Achieve a minimum of 7.5 CGPA
- Clear all previous-year subjects
- Adhere to the institution's code of conduct
- Meet programme-specific requirements (if applicable)

To support students from diverse backgrounds, the following fee waivers are offered:

- **10% Fee Waiver for Applicants from Kashmir & North East India: (First year tuition fee)**

This waiver is available to candidates who are residents of Jammu and Kashmir or any of the North-Eastern states of India.

- **10% Fee Waiver for Children of Defence Personnel:(First year tuition fee)**

Children of active or retired defence personnel are eligible for a 10% fee waiver to acknowledge their contributions and sacrifices.

- **10% Fee Waiver for Applicants from Nepal: (First year tuition fee)**

Applicants from Nepal will receive a 10% fee waiver to encourage international students to pursue their education with us.

- **10% Fee Waiver for Siblings: (First year tuition fee)**

The Fee waiver applies to siblings of currently enrolled students at the institution.

Important Notes:

For the second year onwards, continuation of any scholarships will be subject to the Scholarship Continuation Policy.

FEES CONCESSION FOR STUDENTS OF HARYANA DOMICILE

In accordance with Sections 35 & 36 of the Haryana Private Universities Act, 2006, IILM University offers fee concessions to students who are residents of Haryana.

QUALIFYING EXAMINATION AND ELIGIBILITY CRITERIA

Eligibility	Scholarship Percentage
UG – Class XII with 90% & above and Family Income less than 3 Lakhs Per Annum	100%

RESERVATION AND FEE STRUCTURE FOR STUDENTS FROM HARYANA

1. Seat Reservation:

- A minimum of 25% of seats for admissions at the university shall be reserved for students of the State of Haryana.
- Within this quota, 10% of the seats shall be specifically reserved for students belonging to the Scheduled Castes of Haryana.

2. Fee Structure for Haryana Domiciles:

- The fee structure for the 25% of students who are domiciles of Haryana shall be based on a merit-cum-means approach and shall be allocated as follows:
 - One-fifth (20%) of the 25% reserved seats shall be granted a full fee concession.
 - Two-fifths (40%) of the 25% reserved seats shall be granted a 50% fee concession.
 - The remaining two-fifths (40%) of the 25% reserved seats shall be granted a 25% fee concession.

DOCUMENTS NEEDED

The documents for submission in case of those students seeking fee concession under Sec 36 of the Act are as follows:

1. Domicile certificate of the State of Haryana.
2. Income Proof stating that the annual income of the parents is equal to or less than Rs 8.00 lacs.
3. Last three years' ITR
4. Bank statements last one year
5. Salary Slip lasts 6 months, if applicable.

CONTINUATION OF ADMISSION SCHOLARSHIPS

Scholarships are awarded on an annual basis, and eligibility for subsequent years of the programme is contingent upon adherence to the scholarship policy. To ensure continued support, recipients must meet the following criteria:

1. **100% Scholarship:**

- Students must attain a position within the top 5% of the merit list for their programme.
- Maintain a minimum CGPA of 9.0 or higher.

2. **70% to 90% Scholarships:**

- Recipients must secure a spot in the top 10% of the merit list.
- Maintain a minimum CGPA of 8.5 or higher.

3. **40% to 60% Scholarships:**

- Students are required to consistently rank within the top 15% of the merit list.
- Maintain a minimum CGPA of 8.0 or higher.

4. **10% to 30% Scholarships:**

- Students are required to consistently rank within the top 20% of the merit list.
- Maintain a minimum CGPA of 8.0 or higher.

Attendance and Conduct:

- Students must maintain an attendance rate exceeding 75% in each semester.
- They should not face any academic or disciplinary restrictions during their course of study.

IMPORTANT SCHOLARSHIP NOTES

1. Single Scholarship Policy:

- Students are not eligible to receive a combination of scholarships and concessions. Only one type of scholarship or concession may be availed, and you will receive the option that offers the greater benefit.

2. Application Requirements:

- To be considered for a scholarship, applications must be submitted with complete details in the prescribed format, along with the necessary Sports/Martyr Certificates and relevant documents. Incomplete applications will not be processed and will be cancelled.

3. Exclusions:

- Please note that scholarships in any category do not cover the costs of boarding and lodging.

4. Fee Payment Process:

- In all scholarship categories, students are initially required to pay the full fees. Any excess amount resulting from the scholarship will be adjusted against the payment for Semester-II.

5. Approval Process:

- The grant of scholarships is subject to the approval of the Scholarship Committee.

6. Limited Availability:

- A limited number of scholarship seats are available, and they are granted on a first-come, first-served basis. Early application is encouraged.

7. Application Deadline:

- The deadline for applying for scholarships for all programmes is August 31, 2026. Please ensure that your application is submitted by this date to be considered for a scholarship.
